



Scott Kennedy Bio

Scott Kennedy is deputy director of the Freeman Chair in China Studies and director of the Project on Chinese Business and Political Economy at CSIS. A leading authority on China's economic policy and its global economic relations, specific areas of focus include industrial policy, business lobbying, multinational business challenges in China, global governance, and philanthropy. Kennedy has been traveling to China for over a quarter century, and he has conducted thousands of interviews across the country with officials, businesses, lawyers, non-profit organizations, and scholars. He is the author of *The Business of Lobbying in China* (Harvard University Press, 2005) and the editor of three books, including *Beyond the Middle Kingdom: Comparative Perspectives on China's Capitalist Transformation* (Stanford University Press, 2011), and *The Dragon's Learning Curve: Global Governance and China* (Routledge, forthcoming). His articles have appeared in a wide array of policy, popular, and academic venues, including the *New York Times*, *Wall Street Journal*, *Foreign Affairs*, *Foreign Policy*, *China Quarterly*, *China Journal*, and the *Journal of Contemporary China*.

For over 14 years, Kennedy was a professor at Indiana University (IU). From 2007 to 2014, he was the director of the Research Center for Chinese Politics & Business, and he was the founding academic director of IU's China Office. From 1993 to 1997, he worked at the Brookings Institution. Kennedy received his Ph.D. in political science from George Washington University and his M.A. in China studies from Johns Hopkins School of Advanced International Studies.

甘思德是国际战略研究中心费和中国研究项目副主任兼中国商务与政治经济研究课题主任。他长期致力于研究中国经济政策以及国际经济关系，在包括产业政策、企业参政议政、跨国公司在华的机遇和挑战、全球治理以及企业公益慈善等领域均有出色研究成果。他的著作有：《中国相声：建交以来美国的对华政策辩论》(Rowman and Littlefield, 2003 年出版)，《在中国游说的事业》(哈佛大学出版社，2005 年出版)，《超越‘中央王国’：中国走向资本主义转型的比较视角》(斯坦福大学出版社，2011 年出版)，以及《龙的学习曲线：全球治理与中国》(Routledge, 即将 2016 出版)。他曾多次在《纽约时报》、《华尔街报》、《Foreign Affairs》、《Foreign Policy》、《China Quarterly》、《China Journal》、《Journal of Contemporary China》等权威刊物上发表文章。他曾在 2000 年到 2014 年间任教于美国印第安那大学政治学系，东亚语言以及文化系和凯莱商学院商务经济与公共政策学系。2007 到 2014 年间他曾担任印大中国政治与商务研究中心主任，并于 2014 年创办印大中国办公室并担任学术主任。
