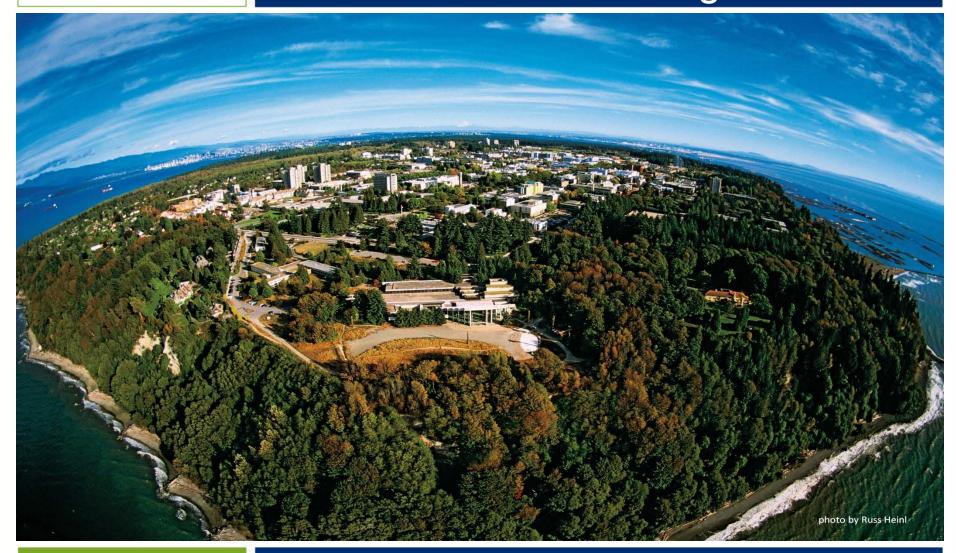


2013 Vancouver International Summer Business Program

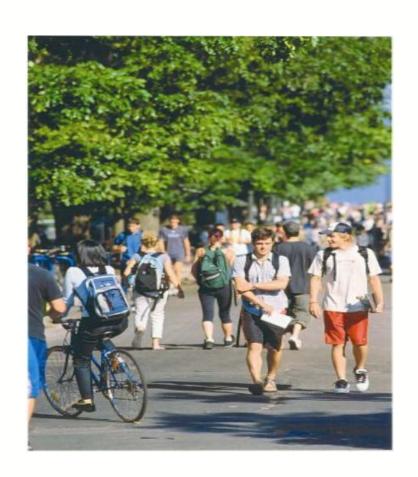

Sauder School of Business at a Glance

In 2010 Sauder was ranked 20th in research productivity among business schools worldwide by the Financial Times

Over 3600 students including 3100 undergraduate, 325 MBA, 45 IMBA, 65 Master of Management, 75 MSc/PhD



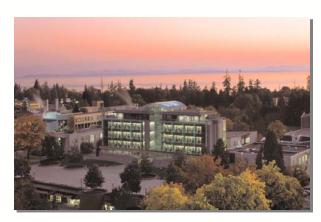
The University of British Columbia (UBC)

Development of general environmental framework for international business studies by drawing on international and development economics, research into government-business relations and studies in comparative socio-cultural systems and political systems.

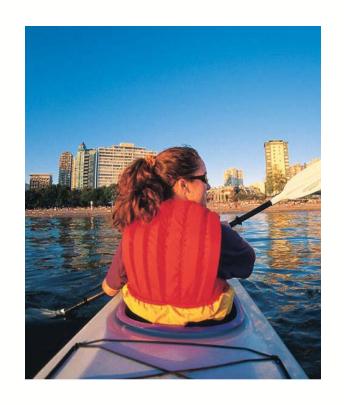


A Typical Day
