"Mandarin Playing Capitalist Games: How China is Reshaping Global Governance." Examines how effectively Chinese government agencies and businesses are learning to participate in global economic regimes and what consequences their involvement has on themselves, China as a whole, other countries, and global governance more generally. Areas of focus include regimes for trade remedies, technical standards, cross-border investment, credit ratings, and commodities markets. Output includes a monograph, multiple articles, and a policy report.

"Perfecting China, Inc.: China's 13th Five-Year Plan." Study uses the 13th Five-Year Plan (2016-2020) as a window into the broader issue of the evolving role of the Chinese state in the economy in the context of domestic political institutions, China's shift from industrial catch-up toward innovation, and greater integration into global markets. The project examines the forthcoming plan's drafting process, its main substance, and the implications for industry. Output includes a major policy report, an academic article, and commentaries.

"Doing Well by Doing Good? Corporate Philanthropy in China." Based on a formal survey of 700 Chinese and foreign companies, the project examines to what extent philanthropy in China is driven by political, business, and altruistic logics, by analyzing what factors determine how much companies contribute, to which causes, and to what effect. Output includes a scholarly article and a policy report. Part of the larger "Initiative on Philanthropy in China" that includes 9 projects by a team of scholars and will result in issuance of a special volume issued by the journal *Voluntas*.

"Taiwan's Economic Dependence on China: Myth & Reality." This study examines the extent to which industries in Taiwan have become dependent on trade and investment with mainland China, the potential positive and negative effects of this relationship, and alternative policy proposals to reduce this dependence, including incentives to develop commercial ties with others and join emerging regional trade and investment arrangements. Output will be a policy report.
